Investment Related Activities

Geneos is a securities broker-dealer (a member of FINRA, SIPC) and an investment adviser registered with the Securities and Exchange Commission. In addition, Mr. Denno is also a licensed insurance agent. He may receive compensation for his activities as a registered representative or insurance agent.

As a registered representative of Geneos, Mr. Denno may recommend securities or insurance products offered by Geneos, and receive normal commissions if products are purchased through him. Thus, a conflict of interest exists between the interests of Mr. Denno and those of our advisory clients. Our financial planning, 401(k) and non-discretionary clients are under no obligation to purchase products recommended by Mr. Denno. No client is obligated to place securities transactions or purchase insurance through Geneos.

Non-Investment-Related Activities

Mr. Denno is an agent of TCG Insurance Agency, which is an independent insurance agency providing insurance products and services such as property and casualty and disability. This firm may provide insurance services to advisory clients for separate and typical compensation. This presents a conflict of interest in that Mr. Denno has an incentive to recommend this firm to advisory clients in need of insurance services. No advisory client is obligated to use this insurance agency, and no insurance client is obligated to use our advisory services.
